



Shortlisting of Candidates for Document Verification for CEN 01/2019 (NTPC G & UG)
LEVEL - 3 (Round-1)

- 1) Candidates bearing the Roll Numbers listed herein under have been provisionally shortlisted for the Document Verification (DV) for the posts notified in Pay Level – 3, based on their score in 2nd stage CBT and the priority for various posts furnished by them in the online application. The candidates called for DV to Pay level-6 & level-5 but could not be empanelled, due to reasons like being absent, lower medical fitness etc., are also considered for posts in Level 3 based on their merit and according to their Medical fitness, as per Sl.no 6 of Notice on document verification process dated 14.09.2022.
- 2) The Document Verification (DV) will commence from 30-01-2023 onwards, Candidates are advised to report to Railway Recruitment Board, No. 18, Millers Road (Behind Cantonment Railway Station), Bengaluru - 560046, as per scheduled date and time mentioned below. Candidates scheduled for DV will get an email and SMS to download their e-call letter from RRB Website.
- 3) Those candidates who will be called for Document Verification may note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of concerned RRB on the next day of the DV. The candidates are required to come prepared to stay for more than four days for DV/Medical examination at their own cost. Candidates have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals/Health Unit for the medical examination. In rare cases, where the investigation like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital/Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory/hospital.
- 4) The shortlisted candidates for DV should produce all the original documents along with two sets of photocopies in A4 size as detailed in the CEN and e-call letter.
- 5) Candidature of all the shortlisted candidates for Document Verification is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways.
- 6) Additional DV will be conducted to fill up the remaining vacancies and shortfall, if any, as and when necessary.
- 7) While every care has been taken in preparing the list of candidates shortlisted for Document Verification, RRB reserves the right to rectify any inadvertent error or typographical or printing mistakes. RRB regrets for the inability to entertain any correspondence from unsuccessful candidates.
- 8) IMPORTANT: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerised and the selection is based purely on the merit of the candidates.
- 9) Candidates are advised to regularly visit RRB's official website for the updates.

This portal will be active for uploading from 10 days prior to date of DV and closes on the date of DV.

2. Candidates wearing spectacles are advised to carry the same for medical examination.

3. Candidates are advised to strictly adhere to COVID norms as per Advisory issued by Government of Karnataka.

4. Block date for verification of original documents for absentee candidates: 06-02-2023.

It must be noted that failure to report for the Document Verification on the scheduled date will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a University/Government examination or due to sickness of the candidate. No other reason for absence will be considered. No fresh e-call letter will be issued.
